Protecting Our Lake:

- Lake Steward Report : Jim Hartog
 - o sampling reports are behind in consolidation
 - Measurements are not all being done at the same time as previous years due to covid, so rather than create data integrity issues, measurements were not taken
 - o In general Water looks good
 - LDD / Spongy moths reduced, not much seen
- Lake Health: Margi Colquhoun
 - Key is natural shoreline

- Plant behind rocky shores native plants
- Guest Speaker Paul Smith Park Superintendents KHSS
 - o First year of normal operations since Covid
 - Park biologist finalize park management plan
 - long term monitoring program ecologist Forest plots, work in partnership with Trent University for sampling, snake monitoring, turtle cages - successful 125 hatchlings, prescribed juniper burn to preserve limestone alvar habitat , interpretive legacy trail (near parking lot) selected for habitat (well worth seeing),
 - Questions/Discussions:
 - Mary Louise Colquhoun: weeds more than usual do we know what kind and where they came from - are they native?
 - nothing invasive has been found (Paul Smith)
 - Sue Murray ATVs on lake can there be signs to discourage ATV?
 - There is not to be ATVs in the park.
 - Currently not enforced.
 - LCLCA could introduce signage
 - Ian Godfrey what snakes are being seen?
 - Ringneck brown snakes, garter snakes, water snakes, Eastern hognose, green snakes, milk snake, skinks,

Map the Lake Project: Jim Hartog and Henry Decock

- Need someone with technical skills to create the map
- Ultimately 2'x3' map for each cottager
- Committee to assess inclusion, rules
- Thoughts on GPS trails, etc.
- Naming islands participants from cottagers

- Contact Jim or Henry to let them know you are interested
 - o Feedback to map the lake:
 - Murray Rochon Trails if the map go on the internet how much attention do we want? People would get hard copy. The committee would determine how it is distributed
 - Leslie Guyatt document control is important even when sent to friends or family.
 - Jim Hartog trails are in good shape because of ATV users with chain saws maintain them, but don't advertise - approach/avoidance
 - Mary Louise Colquhoun- ditto if in cottages, people may take photosadvertise. Need to be cautious about distribution and publication

Guest Speaker: Mayor Carolyn Amyotte

- Floating homes looking at motions to prohibit
- Short Term Rentals looking at what needs to be done. Finding a balance (Chris Challenger is doing the analysis). Will keep cottagers informed
- Hwy 28: safety, working with OPP and MTO to get the community safety zones.
 Working to reduce speed through Apsley area
- Shoreline looking at guidelines, but also with the awareness of regulation. Fund to support them. Safe access to areas. Educate, educate, educate. Committee to review zoning bylaws for conformance. Zoning requests looking for revegetation plan (native shrubs)
- Fireworks bylaw restricted to long weekend timeframe
- Boat cleaning clean before changing lakes. Boat washing station. Include in budget.
 Available for lakes within the municipality. work with part management. (Chandos is an example). Look at the initiative you need for the particular lake
- Q&A:
 - Sayers Foodland it is being built
 - early 2023 target completion.
 - Population of Apsley:
 - approx 3,000. In summer 15,000. Within Apsley approx 300
 - Why did Lion's cut down trees-
 - Park revitalization program expanded for parking for more sports fields
 - Safety zones
 - has there been more enforcement? Yes. There is more. There could always be more, but OPP is here more. Educate people
 - O When can a stop sign or signal lights be justified?
 - This is MTO regulation (Mayor Amyotte will inquire). But turning lanes are needed and this is on the list.
 - Hardware store on Sunday
 - private business ask Home Hardware managers. Not in the Mayor's hands
 - Cycle lanes on Hwy 28

- are there any considered? Paved shoulders help to improve the road and are helpful to bikers and walkers. May not be designated but it does improve safety
- O When will the MPAC assessments come out?
 - Not known, but keep in mind- tax rates are proportionate to the need, so even with increases taxes would be affected proportionally
- Anstruther Lake road guard rails are they regulation? Not wide enough to allow for trucks
 - Motion: Calvin Northover Redo Anstruther Lake Road guard rails and width of entry. Seconded: Leslie Guyatt Lot 57. All in favour. LCLCA Executive will take forward to the municipality.
